Dear General DeJoy,

Benjamin Franklin's resume included two incredibly important jobs: Speaker of the Pennsylvania Assembly and Postmaster General of the United States. In either role, Mr. Franklin would have been as appalled at the outrageous attack on the United States Postal Service as we are.

The USPS is enshrined in the United States Constitution and is literally a lifeline for millions of Americans who count on their mail carriers to bring medicine and money, to maintain the commerce of the nation and, now more than ever, to allow at-risk citizens to exercise their constitutional right to vote safely and securely via a mail-in ballot.

Slowing down mail service, removing automated sorting machines and even removing mailboxes from corners will force people to make a terrible choice: risk having their ballot thrown away because it didn't arrive on time, or risk a crowded polling place with the potential of a COVID-19 infection. This is unacceptable, and the people will not stand for it.

There is nothing more American than a free and fair election, and the actions you have taken to slow down mail delivery directly impact the integrity of the upcoming election. Pennsylvania counties are already overburdened with the expected increase in mail-in ballots because of the coronavirus pandemic; taking away the resources of the USPS is simply unconscionable.

Our constituents have a constitutional right to vote and Pennsylvanians who choose to have their voices heard through mail-in voting should not have those voices silenced or their constitutional rights violated by your actions.

As you are aware, the USPS employs nearly 700,000 Americans in literally every municipality in America. Nearly half of them are people of color and more than 100,000 are military veterans. They provide a service to rural areas that a private company will have no financial interest in matching.
