I'm happy to report that we were able to secure more than \$20 million in new funding for housing, economic development, transportation, environmental restoration and other community needs.

In Harrisburg, we passed a budget that will dramatically change the way we fund our public schools and strengthen real-world programs and services for residents. (You can read more about that in the pages to follow.)

A BUDGET WITH THE RIGHT PRIORITIES

The new state budget we passed this summer has the right priorities, especially when it comes to fixing our broken public education funding system.

For decades, Pennsylvania's failure to adequately fund our public schools has left students in less-affluent ZIP codes with fewer resources – and residents carrying an unfair property tax burden. By investing \$1.3 billion in our public schools through a new formula that targets chronically underfunded districts, the new plan will begin to start leveling the playing field for kids in all districts.

The new plan increases funding to our own school districts by **\$13.4 million** and will ensure

across-the-board increases to our schools.

The budget also provides reimbursements to each school district for cyber charter tuition payments, and it adds more funding for student safety and mental health resources.

Housing and other essential needs are priorities of the new budget, which increases funding for public transportation, affordable housing, subsidized childcare services, county mental health initiatives, homelessness assistance, domestic violence prevention, nonprofit security, and other critical programs. Thanks to a new investment that will establish a statewide right-to-counsel program, eligible residents



facing eviction will have legal representation against deep-pocket corporate landlords.

The new plan may not be perfect – no budget ever is – but it makes smart investments to address real-world issues – all without adding any new taxes. To me, that's a win for our community.

BRINGING YOUR TAX DOLLARS BACK HOME

I'm excited to report that since the start of this year, I have helped secure more than **\$20 million** to boost resources and programs in our district. Highlights include:

- More than \$6 million to expand affordable housing, including funding and tax credits to support construction of new developments in Homewood and Wilkinsburg and additional funding to expand low-income housing opportunities across our region.
- Nearly \$6 million for economic development and community improvements, including funding for continued development of the old Westinghouse building and the Carrie Blast Furnaces site, and funding for multiple park and recreation improvements.
- Nearly \$3.3 million for environmental projects, including funding to improve stormwater management

and remedy the environmental impacts to Chalfant Run caused by acid mine drainage.

- Nearly \$2.6 million for transportation improvements, including funding for projects in Wilkinsburg, Swissvale, and along the Braddock Avenue corridor in Edgewood.
- Nearly \$1.4 million to boost safety for area schools.
- \$560,000 to expand community services and outreach, including funding to allow Gwen's Girls in Wilkinsburg to expand and additional funding to support youth anti-violence and area food programs.
- More than \$261,000 to bolster resources for first responders, including funding for district fire and EMS companies and for the Eastern Regional Mon Valley Police Department our new, regionalized force serving East Pittsburgh, Rankin, and North Braddock.

ACCESSING A LIFESAVING TOOL – WITH NO QUESTIONS ASKED

Peggy, a district resident, recently shared with me the heartbreaking news that her son had died after unknowingly taking drugs laced with fentanyl. She asked me to help find a way to keep other people from dying like her son had.

Although there are no easy solutions to issues like addiction or adulterated drugs, there is something I can do to help – by making sure everyone is aware that lifesaving fentanyl test strips are available for free from my 501 Braddock Ave. district office or from public libraries throughout our district – with no questions asked.

Recovery is possible, but we have to keep people alive so they can find their way out of addiction. This tiny piece of paper can help reduce their risk of overdose until that happens.



WORKING TO END A VICIOUS HOUSING CYCLE

Earlier this year, my colleagues and I hosted a joint House and Senate Policy Committee hearing in Wilkinsburg to garner support for our bill to seal eviction records. We heard testimony about how an eviction can remain on a person's record for years and ruin their chances of finding housing – even if the eviction was caused by domestic violence or other circumstances beyond their control.

It's a vicious cycle with devastating consequences, and it needs to end. I'll be working in the months ahead to advance our legislation to a vote.





PENNSYLVANIA STATE POLICE DEVELOPS CARD FOR PEOPLE ON THE AUTISM SPECTRUM

To help improve interactions between law enforcement and people on the autism spectrum, the Pennsylvania State Police has created an information card that folks can print out and carry in their wallet (or save on their phone) to present to police officers. PAYMENTS GOING OUT UNDER PROPERTY TAX/ RENT REBATE PROGRAM!

Last year, I was proud to help expand the Property Tax/Rent Rebate Program so that it now serves more people and provides larger rebates. The state Department of Revenue is currently processing rebates and will continue to accept applications through Dec. 31.

The program is available to residents 65 or older, widows and widowers 50 or older, and permanently disabled residents 18 or older. The annual income limit for homeowners and renters is \$45,000, and half of Social Security income is excluded for eligibility purposes.

Be sure to bring all earned income tax forms (1099, SSI, W2s, etc.), copies of all paid tax bills (for homeowners), and copies of a signed certificate from the landlord (for renters).



IS YOUR HOME LEAD SAFE?

Lead exposure is particularly dangerous to young children and can cause brain damage. The Allegheny Lead-Safe Homes Program offers qualifying homeowners and renters free lead-paint testing and the services of a certified lead-abatement contractor to stabilize or eliminate lead paint. DO YOU HAVE UNCLAIMED PROPERTY WITH THE STATE TREASURY?

Earlier this year, we helped several residents recover more than \$600,000 in unclaimed property! While we can't guarantee that kind of result for everyone, we can encourage folks to search – and we can help! The state Treasury reports that it's holding billions in unclaimed property and that one in 10 Pennsylvanians has property waiting for them. Stop by my district office so we can help you search the unclaimed property database and recover any property waiting for you!
